BRITISH COLUMBIA: Max 45 Liters (60 Bottles 0,750) / Customs taxes: 115% surcharge + 10-15% of GST*/HST** + excise

MANITOBA: No limits / Customs taxes: 20% surcharge + excise

ONTARIO: Max 45 Liters (60 Bottles 0,750) / Customs taxes: 105% surcharge + 13% of GST*/HST** + excise

QUEBEC: Max 45 Liters (60 Bottles 0,750) / Customs taxes: 100% at the border + 15%

SOUTH KOREA: Maximum 12 bottles per shipment / Customs taxes: 50-60% of declared value

CHINA: Maximum 3 bottles per shipment. Due to frequent changes on restrictions, it is suggested to check with your MBE Store before shipping.

HONG KONG: No limits / Customs taxes: not applicable

MACAU: Maximum 12 bottles per shipment / Customs taxes: 40-70% of declared value

JAPAN: No limits / Customs taxes: 15% of declared value + VAT 10%

SINGAPORE: Maximum 68 Liters (90 bottles 0,750) per shipment / Customs taxes: excise €55 per liter + €5 per bottle + 5% di GST (Goods and Services Tax) + VAT 7%

TAIWAN: Maximum 6 bottles per shipment / Customs taxes: 40-70% of declared value

PHILIPPINES: Maximum 6 bottles per shipment

AUSTRALIA: No limits / Customs taxes: 29% Wine Equalization Tax (WET) + 10% GST (Goods and Services Tax) + 5% customs rights / Deliveries to Queensland and Northern Territories are not permitted
